The West Bengal Minorities' Development & Finance Corporation invites ONLINE applications from meritorious students belonging to Minority Communities (i.e. Muslim, Christian, Sikh, Buddhist, Parsees and Jain) for the year 2017-18.

### IMPORTANT INSTRUCTIONS:-

- > Eligible students are to apply ONLINE at [www.scholarships.gov.in](http://www.scholarships.gov.in).
- > Student must be a citizen of India and domicile of West Bengal.
- > Students having AADHAAR number are advised to register with it, as preference will be given to AADHAAR seeded eligible students during disbursement. This will enable in directly crediting scholarship amount to student AADHAAR linked bank account through Aadhaar Payment Bridge in fast track mode.
- > The bank account must be an active account number. One registration must be done with one bank account number. However, relaxation for two registrations are allowed for pre-matric application only.
- > Student should have obtained minimum 50% marks in the LAST FINAL Examination.
- > APPLICANTS IN RECEIPT OF SCHOLARSHIP BENEFIT LAST YEAR AND HAVING A PERMANENT ID MUST REPEAT MUST APPLY UNDER RENEWAL CATEGORY ONLY.
- > Students who are applying for the first time will have to submit application as FRESH candidate.
- > One registration must be done with one mobile number. However, relaxation for two registrations are allowed for pre-matric application only. All communication will be made on this number.

### POST MATRIC STIPEND UNDER TALENT SUPPORT PROGRAM

- 1) Students pursuing Higher Secondary, GRADUATION, POST GRADUATION, M.PHIL, Ph.D, etc. courses are eligible.
- 2) Student should have passed with less than 50% marks in the LAST FINAL examination and domiciled in West Bengal.
- 3) Annual family income of the applicant should not exceed `2(TWO) Lakh
- 4) All fresh and renewal students MUST apply ONLINE for the period from 1st July, 2017 to 31st October, 2017.

- 6) Institute must be located within the state.
