Subject: Administrative approval of Rs. 7,21,59,147/- (Rupees Seven crore twenty one lakh ,fifty nine thousand one hundred and forty seven) only for extending 34 Mbps internet connectivity over OFC through WBSWAN at 66 Govt Polytechnics

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord Administrative Approval for extending 34 Mbps internet connectivity over Optical Fibre Cable (OFC) through WBSWAN at 66 Govt Polytechnics, Webel Technology Limited (WTL) being the implementing agency, at an estimated total cost of Rs. 7,21,59,147/- ((Rupees seven crore twenty one lakh fifty nine thousand one hundred and forty seven) only. The sum of Rs. 7,21,59,147/- will include one-time installation charges for 34 Mbps link through OFC payable to BSNL in advance amounting Rs 2,27,90,957/-, bandwidth charge (34 Mbps) for one year payable to BSNL in advance amounting Rs 2,98,28,098/-, cost of router, license, UPS and battery rack with three years' on-site warranty, UPS battery with 2 years' onsite warranty, facility management support for one personnel for two years for a total amount of Rs 1,77,63,720/-. Besides, administrative cost for procurement and supply and system integration, project management charges each @5% calculated on Rs 1,77,63,720/- have also been considered with the above project cost. Approval is also accorded to the D-I-C, DTET for advance drawal of an amount of Rs 5,26,19,055/- (Rupees five crore twenty six lakh nineteen thousand and fifty five) only for making payment to BSNL for one-time installation charge and bandwidth charge for one year. Sanction of fund through IFMS will be issued accordingly.

The concerned authority of WTL is hereby authorised to take up the work immediately in consultation with the DTET.

This order issues with the approval of appropriate authority of this Department and with the concurrence of the Finance Department (Group T) vide U.O. No. Group T/2018-19/0727 dated 17.092018.
