ORDER

In supersession of this department's previous order, the Governor is pleased to constitute Governing Body for the Government Polytechnics with the following composition:

1. Sub- Divisional Officer of the concerned Sub- Division (for Polytechnics located in Kolkata an Industrialist / Educationist of repute who is interested in development of technical education and has demonstrated an interest in promotion of quality education may be nominated by the Govt.) ---Chairman
2. Local MLA (nominee of the MLA in case he/she is an MIC/MOS) --- Member
3. Block Development Officer of the concerned Block (for Polytechnics located in Kolkata, an officer to be nominated by the Commissioner, Kolkata Municipal Corporation) --- Member
4. General Manager, D.I.C (for Polytechnics located in Kolkata, an officer nominated by Director of Industries not below the rank of Asst. Director) ---Member
5. Nominee of AICTE Regional Officer (Ex- Officio) ---Member
6. An Industrialist /Technologist / Educationist to be nominated by the concerned Regional Committee as nominee of the AICTE, out of the panel approved by the Chairman of the Council ---Member
7. An officer not below the rank of Dy. Director of Technical Education & Training or Dy. Director of Industrial Training to be nominated by the State Govt. --- Member
8. Nominee of West Bengal State Council of Technical and Vocational Education and Skill Development ---Member
9. An Industrialist /Technologist/ Educationist from the region nominated by the State Govt. ---Member
10. Two persons (one from Lecturer and other from Technical / Supporting / Office staff to be nominated by the Head of the Institute.) ---Member
11. Principal of the Institute ---Member Secretary

The Governing Body is being constituted for a period of three (3) years and is hereby empowered to function beyond this period till a new body is constituted by the Government.

This order issues with the approval of the competent authority and will take immediate effect.


